Hi Pan:

I heard back from Faye Cline this morning:

1) PO 101367 -THE AWARD WAS FOR \$100,000 FOR THE PERIOD 7/1/97 - 6/30/98. We actually spent \$94,978.36 which UVa billed NRAO for. The \$5,021.64 is the unspent balance of the \$100,000 award.

2) PO 54548 -UVA is submitting the final invoice to NRAO at this time. This invoice will be for \$22,715.16 of the \$29,754.68 which will leave \$7,039.52 unspent and unbilled. The award was for \$150,000 FOR THE PERIOD 7/1/98-6/30/99.

I had been led to believe that we had spent both accounts down to less than \$1,000. I have to admit that I leave the 'finances' mostly to Susan so I can concentrate on the research. Since the award periods for both of these accounts have expired, UVa will not let me now spend the \$12,061.16 and bill NRAO unless some notification from NRAO is made. If NRAO is willing, it appears that the options are for NRAO: (A) to officially provide time extensions to keep the accounts open, or (B) to officially issue a modification to the new PO for the current year and increase the award by \$12,061.16 UVa would have to provide a budget indicating how the \$12,061.16 would be used, or (C) other scheme with which NRAO is comfortable.
